AMCC CONSTITUTION, Section 3. OBJECTIVES

The objectives of the club shall be the encouragement and development of purebred Alaskan Malamutes by:

- (a) educating members and the public at large via distribution of accurate information about the breed,
- (b) encouraging and promoting the breeding of purebred Alaskan Malamutes by doing all possible to bring their qualities to perfection,
- (c) urging members and breeders to accept the standard of the Breed as approved by the Canadian Kennel Club as the only standard of excellence by which the Alaskan Malamute shall be judged and to work towards eliminating genetic defects as they become known to exist in the breed,
- (d) encouraging responsible pet ownership and be available to provide assistance to pet owners,
- (e) doing all in its power to protect and advance the interests of the Breed by encouraging and promoting sportsman-like competition at dog shows, sled dog trials and obedience trials,
- (f) conducting sanctioned and approved events under the rules of the Canadian Kennel Club, and abiding by the principles of The Canadian Kennel Club Code of Ethics.
- (g) furthering the welfare of dogs generally and donating money or making contributions to organizations or projects which have either directly or indirectly, the benefit and welfare of dogs as an objective.
